According to Claridge, the form of the hyperbolic expression of thousands of miles is the numerical hyperbole because the expression the speaker use number as one way to create hyperbolic meaning. The intended meaning of thousands of miles by the speaker can be in the form of "Sorbonne university is very far from Avonlea".

The quote below shows the role of superlative.

Anne: At the most **beautiful kingdom** in the world.

An expression of the most beautiful kingdom in the world is hyperbole. Hyperbole is an exaggerated statement by a speaker according to Claridge. Referred to Claridge, the form of the hyperbolic expression of the most beautiful kingdom in the world

is the role of superlative. The intended meaning of the most beautiful kingdom in the world by the speaker can be in the form of Kingdom is very very beautiful. The data below shows a comparison of the form of hyperbole.

Marilla: Quick like a bunny.

An expression of Quick like a bunny is hyperbole. Hyperbole is an exaggerated statement by a speaker as stated by Claridge. Referred to Claridge, the form of the hyperbolic expression of Quick like a bunny is a comparative hyperbole because, in the expression, the woman (she) is compared with a bunny. It is an exaggerated statement where it is almost impossible for someone to run as fast as a rabbit. The intended meaning of Quick like a bunny by the speaker can be in the form of that they must hurry as fast as possible in order to reach their destination on time.
