It is usually held during a night dinner or a cafe, small bar, or just food court event. This makes stand-up comedy easier to reach yet dynamic and effective because we don't need a large stage or a massive event to start a show. When someone has made the communication by using the humor inside, at the moment we do not realize that we are laughing at the jokes. We usually laugh after hearing a joke in a statement, opinion, or comment about something.

What is about to discuss in this research is how the audience supposes to know and understand what is the humor implied in every utterance and how the speakers could make the audience understand what are they trying to deliver, cause in every occasion the speakers are intended to fail cooperative principle and in this research, we will also know that as a speaker, the comedian has some kind of formula and step when it performed so the audience will laugh.
