THE ANALYSIS OF FIGURATIVE LANGUAGE IN THE LYRICS RICHARD MARX SONGS

ABSTRACT

This study discusses the analysis of figurative language in Richard Marx's song lyrics. This study uses a qualitative descriptive method. This study uses Perrine's (1974) theory [1]. The purpose of this study is to identify the types of figurative language contained in Richard Marx's song lyrics and to find out the meaning of the figurative language used in Richard Marx. The researcher found that there were 50 figurative languages from 8 songs analyzed in Richard Marx's song, namely 10 similes, 19 metaphors, 6 personifications, 2 metonyms, 1 symbolism, 1 paradox, 10 hyperboles, and 1 irony. The writer also finds that there are many connotative meanings used in every song lyric which contains figurative language from Richard Marx.

INTRODUCTION

The series of several combinations of words used will usually form a song consisting of several stanzas that will form the lyrics. Song lyrics are one of the determining factors in the success of a song. In the lyrics of the song, there are many meanings that can be interpreted, for example, connotative meaning. Connotative meaning refers to the use of a word to suggest a different association than its literal meaning, According to Griffith (2006) semantics is the study of the meaning of words and the meaning of sentences, abstracted from the context of use used [2].

(Abrams, 1999) stated figurative language is a striking deviation from what language users understand as the standard meaning of words, or the standard sequence of words, in order to achieve some special meaning or effect [3].

Many studies on figurative language have been carried out by several researchers, one of which is Sharndama, E. C., & Suleiman, J. B. (2013) entitled Analysis of figurative language in two traditional songs of burial of the Kilba tribe in Adamawa State [4]. The results of their study reveal that figurative languages such as metaphors, similes, images, symbolism, rhetorical questions, among others, abound in Kilba's traditional funeral song. This study is entitled "The Analysis of Figurative Language in the Lyrics of Richard Marx Songs". This study will examine the types of figurative language and the meanings used in the types of figurative language found in eight songs from different albums.

RESEARCH METHOD

This study used a qualitative descriptive method in analyzing the data in this study. According to (Fraenkel, Wallen, & Hyun, 2012) qualitative research is defined as a research study that investigates the quality of relationships, activities, situations, or materials [5].

The subjects in this study were eight selected Richard Marx songs and the collection and coding technique in this study was to collect data sources taken from the internet and observe the lyrics of the songs.

After observing the lyrics, the research classifies the types of figurative language and explains the meaning of the figurative language used, and makes a percentage table to see which figurative language is used the most and which figurative language is used least.

The analysis shows the figurative language and meaning used in each of Richard Marx's song lyrics.

CONCLUSION AND SUGGESTIONS

The researcher found that there were 50 figurative language data. They include 10 similes, 19 metaphors, 6 personifications, 2 metonyms, 1 symbolism, 1 paradox, 10 hyperboles, and 1 irony. The most widely used figurative language is a metaphor, 19 data. The second is simile and hyperbole. And the least used figurative language is symbolism, paradox, and irony. Besides that, this research is focused on analyzing the types and meanings of figurative language in selected Richard Marx song lyrics. Readers or other researchers who are interested in doing this kind of research should have a better understanding of figurative language and

how to interpret the meaning of the figurative language used.
